THAT the CAO and City Clerk **EXECUTE** any amendment(s) as may be required, provided that the amendments(s) are within approved budget amounts, pursuant to Purchasing By-Law 93-2012 and amendments thereto, satisfactory in legal form to the City Solicitor, in financial content to the City Treasurer and in technical content to the Executive Director, Parks, Recreation and Facilities.
